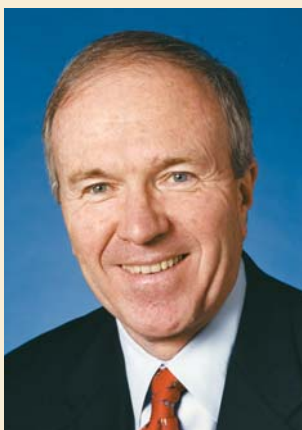

James P. Gallagher, Ph.D.,  
President of Philadelphia University,  
To Retire

Philadelphia University President James P. Gallagher, Ph.D., who during 22 years has led the University's transformation into a vibrant, interdisciplinary and forward-thinking institution, announced his intention to retire March 7 during the University's Board of Trustees meeting. Dr. Gallagher will remain as president until a successor has been named.

"I am very proud of all that we have accomplished at Philadelphia University," Dr. Gallagher said. "Just this past year, we opened The Kanbar Campus Center and the Athletic and Recreation Center — two magnificent buildings, and closed the most successful fundraising campaign in University history. It is the perfect time for me to allow a new leader to continue our mission as a thriving community focused on the intellectual and personal growth of our students."

During Dr. Gallagher's tenure, Philadelphia University has more than quadrupled its applications for admission, expanded its academic offerings, constructed state-of-the-art facilities, increased its endowment and raised its national and international profile as a quality institution of higher learning. One of the longest-serving college presidents in the country, Dr. Gallagher's successful leadership has ensured the continued vitality of educational, social and cultural life on campus.

A Search Committee, led by University Trustee Donald Redlinger, former senior vice president of Human Resources and Communications for Honeywell International, Inc., and consisting of trustees, faculty, staff and students, is currently searching for a suitable successor. Dr. Gallagher will remain as president until a new president has been chosen.

It has been an incredible year for Philadelphia University, and one that allows me to retire with the confidence that this university has an exciting future. I thank you for your support and generosity, especially during this past year, for you have made it possible to complete the Kanbar Campus Center and the Athletic and Recreation Center, both of which have invigorated and transformed our community. There is a renewed air of excitement across campus which is propelling us on a journey of unlimited opportunities.

I am proud that our mutual efforts in *Experience the Transformation: The Campaign for Philadelphia University* have raised \$20,106,000 to date — surpassing our ambitious target. We were privileged to receive a \$6 million contribution from alumnus Maurice Kanbar '52, the single largest gift in Philadelphia University history, and have added more than \$4 million dollars to our endowment. This success has given us so much to celebrate, but what is most thrilling is the fact that you have given us the impetus and initiative to keep moving to make Philadelphia University even better than it is right now.

We have had outstanding leadership from the Board of Trustees, and specifically, the members of the Campaign Steering Committee. Chair

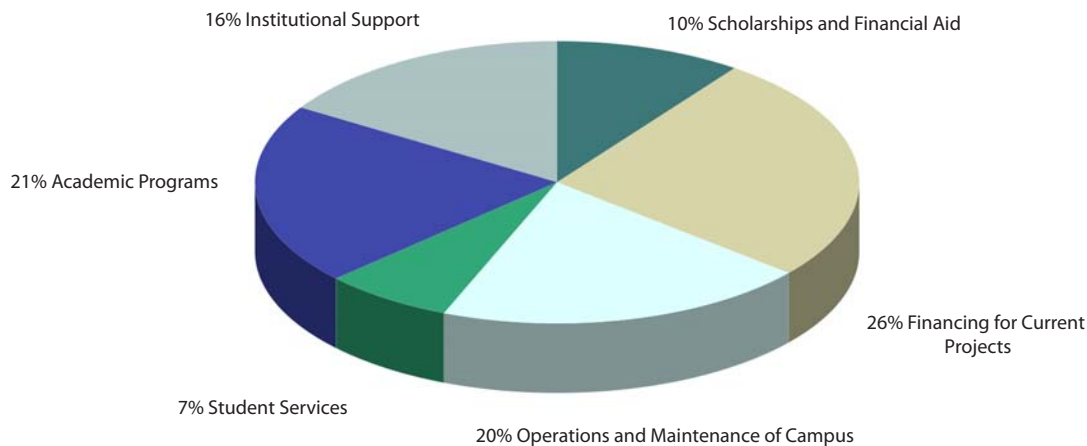

# University Mourns the Passing of Walter "Bucky" Harris



The Philadelphia University community lost one of its most ardent supporters and longtime friends on December 6, 2006, with the passing of Walter "Bucky" Harris, former administrator and coach. Harris, 80, worked in several capacities in his 46 years at the University including director of Athletics as well as director of Physical Plant, but gained national notoriety for his accomplishments as head men's basketball coach.

"The Philadelphia University community is saddened by the sudden death of Bucky Harris, who gave many years of service to the University as a basketball and soccer coach and athletic director," said Philadelphia University President James P. Gallagher, Ph.D. "During his 46 years of service at the University, Bucky Harris took two basketball teams to the NCAA tournament and greatly expanded both intramural and intercollegiate sports programs. He was a true friend to Philadelphia University."

During his tenure as the head men's basketball coach, Harris compiled a 240-56 overall record in 13 seasons and remains the all-time winningest coach in NCAA Division II history in winning percentage. This stretch included winning the Eastern Regional Championship in 1963 when his team was led by two-time All-America and current Rams' coach Herb Magee. Harris also coached the program's first All-American, Charles Barnes in 1958 and led the Rams to a pair of NCAA Tournament appearances.

In addition to basketball, Harris also coached the University's men's soccer team from 1956 through 1960, registering a 20-13-3 mark. As the director of Athletics, Harris was instrumental in expanding the University's intercollegiate programs and intramural program as well as spearheading the addition of tennis courts and a baseball field to campus.

Despite his retirement in 1996, Harris and his wife, Lorraine, remained active at the University with various projects and committees and also established the Billy Harris Scholarship. The scholarship, which is named for Harris' son, a University graduate who sadly passed away from leukemia in 1986, remains the largest endowed scholarship at Philadelphia University.

Harris is survived by his wife, Lorraine; son Walter Jr. "Buddy" and his wife, Cathy, daughter Marianne and her husband Dr. Keith Harrison. Grandchildren include Michael, Walter Buddy III, Brent, Ashley, Bradley, Jonathan, Jennifer, Mark, Katie and Billy. Great-grandchildren are Kyle, Will and Daniel Walter.

"This is a tremendous loss for Philadelphia University," said Magee of Harris. "His accomplishments during his time here are too numerous to list, but his lasting legacy will be the lives he touched along the way with his kindness, generosity and dedication. We will miss him dearly."

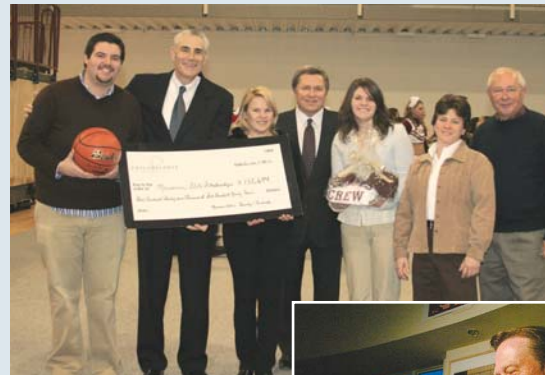
